Important Notice to all Campers!!!

WINSTOCK camping offers primitive sites only with no running water or electrical hookups. We do not allow open campfires (self-contained only - subject to the Fire Marshall Approval), and each campsite is limited to one sleeping unit. We provide fresh water, medical facilities, and one free vehicle-parking pass per campsite. **No pets are allowed**. Campground admission will be open from 3:00pm until 9:00pm on Thursday, June 9th and starting at 9:30am Friday, June 10th. **All campsites are reserved and will be held for you - so there is no rush to get to your site.** This year again the Winsted Fire Department will be holding a Spaghetti Dinner Thursday June 9th starting at 5:00pm and we will also have live music in the beer tent from 7:00pm to 11:00pm. For anyone interested in breakfast, we will be running a shuttle bus every half-hour starting at 7:30am to 11:30am on Saturday. The bus will stop at the BlueNote, downtown Winsted, and also at Glenn's Super Valu.

When you enter the WINSTOCK campgrounds, you will be issued garbage bags for cleanup. Please make sure your site is clean before you leave. Also, every effort was made to assign the campsites that you requested, but as the campgrounds filled up, the next best available site was given. Those of you that requested multiple sites together may notice that your campsite numbers are not in sequence. This is due to the fact that they were placed back-to-back to each other. Please visit our Web Site www.winstockfestival.com to view a campground layout. For the benefit and safety of our campers Winstock will be providing 24 - hour security at the campground entrance. Only authorized vehicles will be allowed to enter. To speed up the process of entering the campground, please make sure that everyone in your vehicle has purchased a ticket so that they can be banded at this time. Remember that everyone in the campgrounds must have a wristband. In the event of wet weather, some or all of our campsites may have to be moved. We will do the best we can to keep your sites together but it may not be possible, so please bear with us. If you have any questions regarding your campsite, please call our toll free number 1-888-946-7865 and our operators will try to answer any of your questions. Also, please remember to bring a non-perishable food item or cash for the McLeod County Food Shelf. Thank you for your continued support and remember to renew your campsite for Winstock 2012 at the information tent.

Extra Vehicle Passes. You will need an extra vehicle for each "motor" that passes through the main entrances. The vehicle pass must be displayed at all times. Also, you must have a campsite in order to purchase additional vehicle passes.

Campground Entrances. In order to keep traffic flowing smoothly to the campgrounds, please watch for your entrance. The entrance to campgrounds A and B are on the south side of county road 5 by the main concert area. Campgrounds C and D are one-quarter mile west of the concert area on county road 5. Campground C is on the south side of county road 5 and campground is on the North side. Campground E is on the east side of County Road 1. The entrance to campground E is off of County Road 1 at the intersection of County Road 5 and County Road 1. Please watch for the entrance signs.

Campground E. For those who are camping in campground E, you will need to cross County Road 1 to enter the concert area. For your safety we are asking that you only cross at the intersection of County Road 1 and County Road 5. You will be able to enter the concert area by walking on the south side of County Road 5 and enter at the VIP entrance. If you have difficulty walking we will also have busses that will be stopping at each campground.

Showers . Watch for showers from Blue Lagoon Mobile Showers at the entrance to campground A and B.

Space Between Campers. The Minnesota Department of Health has requested that a "separation distance of 10 feet be maintained between the sides of adjacent recreational camping vehicles". Watch for more information when you enter the campgrounds.
